Dear Marcia,

I find your response both incorrect and objectionable.

As you should be aware, these documents were initially requested (acknowledged 16th July 2018 15:13), via Wokingham Borough Council's Planning Enquiries email address. So your reference to 10 working days response time is irrelevant, as this was the date of my enquiry for information that should be readily available.

The Statutory Services Administration (Planning) Team were very helpful locating the files and putting them to one side for my pre-arranged visit. However, in spite of this, the documents were removed and some possibly destroyed. To date they have not been made available to me.

As per my email of 10th August 2018 to Manjeet Gill (08:56) and Josie Wragg (08:45), (acknowledged by Amanda Ellison 09:10) the request for documentation (including Plans) remains in place and was delegated to yourself by Josie. The unavailability of this information is both suspicious and unacceptable.

Your attempts to subvert, delay and obstruct are not appreciated and I would urge you to comply with my requests and those of your Management, the elected officers / public servants.

I have copied Manjeet and Josie on this email, as I consider this a further attempt to delay disclosure. As Josie stated "*Wokingham Borough Council are required to keep a copy of planning application decision notices and the approved or refused plans*", so this should not be an issue.

I look forward to receipt of all requested information on Friday 24th August 2018.

Thank you, however this does not address the items delegated to you by Josie Wragg. My enquiry relates to [Plans](#) and to [confirmation of Enforcement action](#). **Wokingham Borough Council are required to keep a copy of planning application decision notices and the approved or refused plans**, so this should not be an issue.

1. Please could your team provide all Plans relating to application 40429, as they are currently not available online.
2. Please could your team also provide Plans relating to application SO/2003/9698 and the B2 Use referred to in that application
3. Please could your team confirm that they have received two reports of Planning Infringement relating to Star Works Treatment Plant?
  - o These were raised via email on Sunday 12th August (to [development.control@wokingham.gov.uk](mailto:development.control@wokingham.gov.uk) and [tim.holton@wokingham.gov.uk](mailto:tim.holton@wokingham.gov.uk) ) and also via your online WBC portal on Monday 13th August, however no acknowledgement has been received since then.
  - o The Environment Agency have confirmed infringements with regards Noise Pollution, following a site visit today, and are already implementing measures.
  - o They have however stated that Enforcement of the Industrial Sprawl highlighted in these reported Infringements; Storage outside of permitted Storage Areas and within 100m of Residential Properties would fall to Wokingham Borough Council Planning Enforcement.
