County Tax Bill Insert Status – A two-sided insert will go in all county property tax bills in October. Susan Rogers reported that the Coalition side of insert is complete, and passed around a printout. The county is working on the Code Red Side. Report on Fire Safe council Board meeting

300 miles are county roads, 900 miles are rural roads – There will be some private grants through FSC for private property road clearance – must be shovel-ready, permissions, waivers etc. Don Thane encourages all FWC to put in some kind of project. There is potentially a large amount of money. Funding comes from OES grants and will be allocated to the Fire Safe Council for disbursement. Applications from Fire Safe Council will be forthcoming.

Need communities to volunteer for Fire Drill in Spring – Send an email to Bob Long (Chairman) about your interest - Boblong162@gmail.com. You can also send an email to Chris Reilly from Alta Sierra, he has helped organize this and can give some guidance. Chris: castle55@yahoo.com This is an opportunity for the land owners to communicate with the fire responders.

211 works – Call 211 rather than 911 for fire information and updates, this keeps the 991 line open for actual emergencies – 211 system is staffed with people who are updated by OES during significant events

OES and neighbors' lot: People have been calling OES and FSC about rural lots that are more than 100 feet from a structure. Unfortunately the enforcement of clearing vacant lots is more difficult because of the distance from structures. Best option is to attempt to get folks to work together.

Cal Fire – Cal Fire is considering remodeling kiosk at Gate Five in the Fairgrounds. They want to make it a demonstration building. This will be funded with grant money.

Marty Main commented that there may be some state money coming down the pipeline from the state for more fire safe clearing. Keep an eye on YubaNet for more information.

Address signs – Bob Long - of the 60 homes in Bob's neighborhood only 6 had the signs. The signs cost 35 dollars, they can be two sided. You need a metal stake (from any hardware store) and some bolts to put the sign up. Signs are available on the Fire Safe Council website. Use a two sided so it's visible from two directions.

The system is working – Jeff Peach shared a letter from Nevada County Consolidated that went to a neighborhood about hazardous vegetation. The system is working.

Subcommittee Status Reports

Evacuation – Chris O'Reilly - Chris shared a fire report from Alta Sierra. The fire was not catastrophic due to good defensible space work by homeowners. Chris shared some signs that have been developed by the committee. The signs are the *Out OK* or *Help Needed*. These will be made available to all communities when completed. He also showed some flexible poles that connect to fire hydrants making them easy to locate. You can go to Nevada County on line and request new road signs.

Enforcement - Dario Davidson - Nothing to report.

Real Estate – Susan Rogers - This is the effort to get the local realtor committee to do a better job educating buyers, sellers and agents about defensible space. Susan has communicated with Rick Nolle who is an agent, lives in a FWC and has offered to help move things along.

Fire Adapted Communities - Jackie Mason – https://fireadaptednetwork.org/ Members are mostly Fire Safe Councils. Should the Coalition become a member? *Homework*, go to the website and do some research. Sort of an extension to what we are doing here with the Coalition.
