- Reduce Hazardous Veg in county with Nevada County Consolidated Fire Dept.
- Defensible Space Program/Inspectors: Hazardous Vegetation Ordinance 2463. Have been rewriting plan this past Winter. Goes before NCounty board in March. More proactive program. Proactively look for higher risk areas and help with fuels reduction. Strictly unincorporated areas (not NCity or GV or Truckee).
- County to send letter (1-2 months) to unincorporated areas remind about ordinance and Def Spc code, and 10/10/15 Fire Wise Roadsides. If not in compliance, fines.
- Private roads are responsible for their own roads too.
- After 2010, if a road is designated Egress Road, one can have a gate, but it has to be unlocked.

Cal trans – hazardous tree removal - update Susan Rogers

- Responsible for veg mgt on Hwy 20 and 49. They see their job as maintenance.
 Keep trees from falling down and obstructing traffic. Starting to look at these trees as a fire hazard.
- Goal to get Cal-Trans to view trees in a new way and reduce fuel load.
- Vote to approve Coalition letters to Gov. Newsom, Cal Trans and Board of Supervisors

• Look at trees in a new way to remove hazardous fuel loads on sides of Hwy 20 and 49 and 174. Yes, overwhelming Yes.
