

Within this Code are important rules about how I will look after and protect your personal information /data. For example, I will keep any information you share with me secure and confidential. I will not share this with another person or organisation. This includes verbal, written and electronic information

- I will only use and refer to your information for the specific purpose of providing you with Solution Focused Hypnotherapy
- I will only disclose information you share with me, to another person, with your consent. The only exception is if I were to be instructed to share information by a Court of Law in the United Kingdom or if I were to have significant concerns about an intention of a person to cause serious harm to themselves or another person
- I am bound by the Code to keep accurate client records. In line with the Data Protection Act, you can request to see all the information I have recorded about you
- I will provide hypnotherapy at the agreed location, at the agreed days and times and for any fees that will always be agreed in advance
- I will provide hypnotherapy to you only if you give your informed consent for me to do so. I will ask you to sign this agreement and give your consent after the free Initial Consultation i.e. after you understand how the therapy works and what to expect during and between the sessions


